INTERNAL REGULATION OF SITE:

- **a- Eligibility:** To be eligible to enter, settle & stay, the site must be authorized by the manager or his representative. He has an obligation of ensure the proper conduct & good order of the campsite & the respect f the application of this Regulation. The fact of staying on the ground implies the acceptation of these rules & commitment to comply.
- **<u>b-Form police:</u>** Everyone who spends at least on night in the site must first submit to the manager for ID & complete the formalities required by the Police. Unaccompanied minors are not permitted on site. The groups are not friends.
- **<u>c- Installation:</u>** The tent or caravan & equipment relating thereto are moved to a specified location as instructed by the manager or his representative
- <u>d- Reception:</u> Open from 8 am to 6.30 pm on Saturdays, you will find all information about the campsite facilities, information on the possibility of shopping, sport facilities & tourist information in general. A suggestion box is available in the Laundromat. Complains will be held in account if they are registered, signed & dated, acurate & timely. Sales at the bar, washing machines & dry tokens . At the reception: Bakery(from8.00am). , postcards, envelops & stamps, tourist informations, washin machins tockens.
- e-Site fees: Fees are paid at the reception. The amounts shall be posted at the entrance of the campsite, out site the office & indoor. They are due by Number of nights spent at the campsite. Then sites must be released before noon. Any excess will be the settlement of an extra night. Users who made a reservation & therefore subject to a contract, proceed to the settlement of their stay upon arrival. Those not subject to any reservation must notify the manager or his representative on the eve of their departure & thus regulate their fees. We do not accept debit or credit cards. Campers intending to leave the site before the opening hour of the office, will do the same. Tenants of caravans or mobile homes who wish to leave before the opening hour of the office will notify the eve of their departure & their bail returned by mail.
- **<u>f- Noise & silence:</u>** The site users are urged to avoid any noise or discussing high amplitude that might disturb neighbours. The sound equipment should be adjusted accordingly. Dogs & other animals should never be left at liberty. They should never be left alone, even locked in the absence of their masters who are civilly responsible. They should take them out regularly off the campsite for their daily needs. The silence will be observed between 22h & 7.30 am. Absolute silence at the close of the campsite bar. No tolerance will be accepted.
- **g-Visitors:** After being authorized by the manager or his representative, visitors may be allowed in the campsite is the sole responsibility of their hosts. Campers may be asked to pay a fee, to the extent that the visitor has access to various services &/ or facilities of the campsite. This fee shall be posted at the entrance & the reception. The cars of visitors are strictly prohibited inside the campsite (visitors car park at the entrance of the campsite).
- **h- Traffic & parking:** Within the campsite, the vehicles must meet the speed limit (5km/h). The traffic is prohibited between 22h & 7.30 am. Only cars belonging to the residents are allowed on site. Only one vehicle is allowed per site. All other vehicle, overnight parking/resident

- i- Common facilities: Each person shall refrain from any action which could affect the cleanliness, hygiene & appearance of the site. All caravan must not empty their wastewaters direct onto the site. Users must necessarily empty their wastewaters (including chemical toilets) in the facilities provided for this purpose. The sorting is required. Recycling is compulsory. Containers are available at the campsite entrance & and thee visitors car park. Washing is strictly prohibited outside containers provided for that purpose. The drying of clothes do not have to support trees & shrubs. It should be discreet & not disturb other tenants. The washing is extended under the full responsibility of its owner. The plants & flowers must be respected & occasionally watered during the summer. It is not allowed to dig the ground to avoid injury to the occupants of the site or nearby. Any damage made to the plantations, fences, land or facilities of the campsite will be the responsibility of its author. Parents are responsible for the actions of their minors children. The site must be left clean & ready for the next occupants to come.
- **j- Security:** You are in a woodland. Only the gas grill is allowed! Stoves must be kept in perfect working condition & not be used in hazardous conditions. Fire extinguishers are available on site., evidenced by red terminals along the main aisles. It is essential to alert management of any accident. A first aid kit is at the reception. Some staff members are qualified first aid. In all case, only the management is authorized to prevent the emergency services.
- **k- Thefts:** The site has no safe, so the customer is fully responsible for its values & will take steps to ensure its own security. Management has no obligation to monitor the campsite. The camper is responsible for its installation & must report the presence of any suspicious person. Although guarding is provided, users are advised to take all necessary precautions to safeguard their equipment & values.
- <u>I- Games:</u> Ball games are not allowed around the caravans or any camping equipment in the campsite. Land & space are available for this purpose At the swimming pool or on the playground, as elsewhere on the field or common facilities, minors children are the sole responsibility of their parents.
- **m- caravans:** In the event you are leaving the campsite more than 24h, please inform reception. Between 14th July & 15th August, site fees will be 17 euros payable when your caravan is unoccupied. Management will not be responsible for equipments which are left on site when you are away.

We ask the residents to respect these site rules & respect their neighbours, & not to disturb the enjoyment of others. Please enjoy your stay with us.
